Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

I would like to request under the Freedom of Information Act data held by Police Service of Northern Ireland on speed cameras in your area. In particular, I would like details of the number of enforcement cameras operational within your area?

Request 2

I would like to know the type of camera – whether they are fixed or variable speed. I would also like to know the number of average speed cameras operational within your area?

Request 3

I would also like to know the location of the top ten cameras within your area with regards to the number of fines issued from 2017 to the date of receipt of this email?

Answer to Request 1-3

The 2022 statistical report will be published at the end of June 2023.

The number and types of camera in operation is summarised for each particular year in the introductory section of each annual report. The reports also provide the total detections in each year by camera type, including those for mobile cameras which operate at a range of sites throughout Northern Ireland.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
