#### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request

I am currently conducting an exploratory study to investigate the relationship between Albanian nationals and cannabis cultivation in the UK.

Using data from NRM referral records, could you please inform me of the number of NRM referrals, broken down into nationalities, which concern cannabis cultivation.

Could I please have the data from 2021, 2020, 2019, 2018 and 2017 presented in a similar format as seen below?

### **Answer**

This financial year is from 1<sup>st</sup> April 2022 and up until 28<sup>th</sup> February 2023, ten Potential Victims of Trafficking (PVoT) who are in the NRM in Northern Ireland alleged that they were the victim of Criminal Exploitation and that it involved the drugs trade; unfortunately we can not specify if this specifically involved cannabis cultivation.

It should be noted that the location of exploitation varies from individual to individual with some alleging exploitation within Northern Ireland and others alleging exploitation outside the UK.
