### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

# Request 1

Under the FOI Act, can you provide records of all incidents of a racist nature reported to the PSNI in the Derry City and Strabane District Council area in each of the last five years, January 2018 to January 2023?

## **Answer**

Financial year figures are published with a district breakdown in our Annual Trends in Hate Motivated Incidents and Crimes Recorded by the Police in Northern Ireland report. Figures for the financial year 2022/23 will be published in the next Incidents and Crimes with a Hate Motivation Recorded by the Police in Northern Ireland on 16<sup>th</sup> May 2023. ### Request 2

Can this be broken down by year and broken down by location - i.e. Derry or Strabane?

#### **Answer**

Financial year figures up to 2021/22 are published for a range of administrative geographies, such as ward and DEA, on the NINIS web portal:

The NINIS portal is being replaced by the NISRA data portal at the end of June 2023. ## Request 3

Can you provide the nationality of the victim in each case?

#### **Answer**

Information on the nationality of victims of racist hate crimes is available on a Northern Ireland level in the Annual Trends and quarterly updates previously mentioned. There is no further breakdown of nationality available, and to provide this information for smaller geographic areas would be disclosive as individuals and communities may be identifiable in the data. Due to the sensitivity of this information it would not be appropriate to provide this.
