Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

In each of the last two financial years (21/22) and (22/23) please state that as a result of committing a motoring offence (speeding and all other offences) in your authority how many (a) fixed penalty notices fines were accepted by motorists and (b) how many drivers accepted places on driving training education courses which were offered as an alternative to a Fixed Penalty Notice fine.

Request 2

During this two year period what was the financial penalty for (a) a Fixed Penalty Notice and (b) the cost of enrolling on a driver training course.

NOTE: If you do not yet have the figures for 22/23 then please just provide the data in relation to 21/22.

Answer

(a) The financial penalty for a Fixed Penalty Notice was a £60 fine, £5 offender levy and 3 points endorsement

(b) The cost of enrolling on a driver training course varies depending on area and provider (course can be done virtually and therefore can be completed by a provider in England or Wales). Costs vary from £84 up to £92 (subject to change)
