Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

I'm writing to request the following under the Freedom of Information Act:

Request 1

What percentage of crimes reported to your force between 6 April 2022 and 5 April 2023 were domestic-abuse? Please provide the raw numbers if possible. If you do not have information that up-to-date, please provide for the first three quarters of the specified period.

Request 2

What percentage of crimes reported to your force between 6 April 2022 and 5 April 2023 were rape? Please provide the raw numbers if possible. If you do not have information that up-to-date, please provide for the first three quarters of the specified period.

Answer

For requests 1 and 2, this information will be available for the period 1st April to 31st March. The Domestic Abuse Incidents and Crimes Recorded by the Police in Northern Ireland Update to 31st March 2023 and the Police Recorded Crime in Northern Ireland Update to 31st March 2023 bulletins just been published on the PSNI website on 16th May 2023. These will provide figures for the number of Domestic Abuse crimes, the number of overall Recorded Crimes, and the number of recorded Rape crimes. Using these raw numbers you will be able to work out the respective percentages. This can be done for older time periods using the figures in previously published bulletins. crime, broken down by offence for the period 2004/05 to 2021/22. This is available on the domestic abuse page of the PSNI website.

Request 3

What percentage of callouts made by your force between 6 April 2022 and 5 April 2023 were for domestic abuse? Please provide the raw numbers if possible. If you do not have information that upto-date, please provide for the first three quarters of the specified period.

Request 4

What percentage of callouts made by your force between 6 April 2022 and 5 April 2023 were for rape? Please provide the raw numbers if possible. If you do not have information that up-to-date, please provide for the first three quarters of the specified period.

Answer for Requests 3 and 4

For the period of 1 April 2022 to 31 March 2023, there were 433,211 incidents. Of these 15,899 (3.66%) were for Domestic Abuse and 353 (0.08%) for Rape.

Request 5

What percentage of your budget between 6 April 2022 and 5 April 2023 went on domestic abuse? Please provide the raw numbers if possible. If you do not have information that up-to-date, please provide for the first three quarters of the specified period.

Answer

Approximately £3.8m (0.45%) for the year from the annual budget of £836m, 2022/23.

Request 6

What percentage of your budget between 6 April 2022 and 5 April 2023 went on rape? Please provide the raw numbers if possible. If you do not have information that up-to-date, please provide for the first three quarters of the specified period.

Answer

Approximately £4.593m (0.55%) for the year from the annual budget of £836m, 2022/23.
