Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

Can you provide me a copy of any policy or guidance documents relating the the psychological screening of officers within Armed Response Unit, Public Protection Unit and Family Liaison Officers?

Answer

There is no policy or guidance documents relating the psychological screening of officers within Armed Response Unit, Public Protection Unit and Family Liaison Officers.

Request 2

Do you routinely screen officers within these roles monitoring their mental health?

Answer

No, however, a pilot psychological screening and surveillance assessment is to be organised with 10 - 15 officers and/or staff starting a new post in a high-risk unit/s (i.e. Public Protection Unit, Cyber Crime, Family Liaison Officers, Crime Scene Investigators, etc.) is due to commence in the Autumn for 24 months.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
