This consultation seeks views on The Police Service of Northern Ireland's (PSNI) use of Spit & Bite Guards. Spit and Bite Guards are a piece of work equipment used to protect officers, staff, and members of the public from assaults by spitting and biting. Spit and Bite Guards were introduced in March 2020 as a temporary tactical option to counter such assaults for the duration of the Coronavirus pandemic. We would welcome your thoughts on the use of Spit and Bite Guards as a tactical option in a post Coronavirus environment.

A Spit and Bite Guard is a breathable, mesh material garment that covers the face and head to prevent the wearer from being able to assault officers, staff and members of the public by means of spitting, thereby reducing the potential of communicable/contagious diseases. PSNI policy on the Use of Spit and Bite Guards is contained in Chapter 16 of the PSNI Conflict Management Manual. The product the PSNI use is the Spit Guard Pro (shown below).
